

## *Dog Class Agreement*

By attending dog training classes and the execution of this agreement, I expressly agree that, K-9 Academy, Rolla Animal Hospital, Animal Health Center of Rolla, Cross Creek Animal Hospital and it's members, it's instructors, it's staff, and it's agents shall not be liable for any damage arising from personal injury or other damage or injury sustained by me, my guests, or my dog, in, on, or about the premises of Rolla Animal Hospital, Animal Health Center of Rolla, Cross Creek Animal Hospital or any other location where said training classes may be held, or as a result of attending, observing, or participation in training classes. I assume full responsibility for any such injury or damage that may occur to me, my guests, or my dog, in, on, or about the facilities and further agree Rolla Animal Hospital, Animal Health Center of Rolla, Cross Creek Animal Hospital shall not be liable for any loss of theft of personal property. I also specifically agree that or Rolla Animal Hospital, Animal Health Center of Rolla, Cross Creek Animal Hospital shall not be responsible for any such injuries, damage, loss, or theft even in the event of negligence by Rolla Animal Hospital, Animal Health Center of Rolla, Cross Creek Animal Hospital, whether such negligence is present at the signing of this agreement or takes place in the future. This waiver does not, however, apply to gross negligence or intentional torts by Rolla Animal Hospital, Animal Health Center of Rolla, Cross Creek Animal Hospital. I further agree to indemnify and hold harmless Rolla Animal Hospital, Animal Health Center of Rolla, Cross Creek Animal Hospital for any damage, injury, loss, or theft, including, but not limited to a reasonable attorney's fee, caused by myself, my guest, or my dog while on the premises of Rolla Animal Hospital, Animal Health Center of Rolla, Cross Creek Animal Hospital or at any other location which such classes may be held. I further agree that this agreement is binding for this and any subsequent class, which I may attend.

Also, since we will be rewarding good behavior with treats please try not to feed your dog approximately 3 hours before each class. When bringing children to class to help with training, the adult must work dog first and then demonstrate to child what the instructor has demonstrated. Refund Policy: After first class you get full refund, If attend second class then %50 will be refunded. Once you attend third class there is no refund. Return check Policy: Any check returned will incur a \$25 fee.
